Objectives

The fund aim is to achieve long-term growth. The fund has a long-term objective of matching the benchmark, gross of charges, over 5 to 7 year periods. This fund invests in a selection of specialist active managers giving exposure to a diversified mix of lower volatility international equities. Non-equity positions may also be held at times. The allocations to managers are regularly reviewed by Mercer and may change over time. The return for the investor will depend on the performance of the portfolio of assets in this fund. The risk profile of this fund is based on the seven year recommended holding period. Investments for longer terms are expected to lower the level of risk and shorter investment terms are expected to increase the level of risk.

Intended Retail Investor

This investment option will appeal to investors who are seeking long-term real growth while being aware of their ability to lose some or all of their investment. Summary Risk Indicator (SRI)

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because Zurich is not able to pay you. Zurich has classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of Zurich to pay you. If Zurich is not able to pay you what is owed, you could lose your entire investment. This fund does not include any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios
