

Medium Risk Investment Strategy

For the Cornmarket Savings Plus - Child's Plan

Objectives

The unit Fund in which the Medium Risk Investment Strategy invests the contributions depends on the number of years to the strategy end date. With at least ten years to go, contributions are invested in the Prisma 5 Fund; with at least five years to go but less than ten, contributions are invested between the Prisma 5 and the Prisma 4 Funds; and with less than five years to go, contributions are invested between the Prisma 4 and Prisma 3 Funds. Any further premiums after the strategy end date will be invested in Prisma 3. With at least five years before the strategy end date but less than ten, the allocation between the Prisma 5 and Prisma 4 funds changes on a gradual basis so that the unit account gradually moves to be 100% invested in Prisma 4 at exactly five years before the strategy end date; less than five years before the strategy end date, the allocation between the Prisma 4 and Prisma 3 funds changes on a gradual basis so that the unit account gradually moves to be 100% invested in Prisma 3 at the strategy end date. The return for the investor will depend on the performance of the portfolio of assets in this investment option. The risk profile of this investment option is based on the seven year recommended holding period. Investments for longer terms are expected to lower the level of risk and shorter investment terms are expected to increase the level of risk.

Intended Retail Investor

This investment option will appeal to investors who are seeking long-term real growth while being aware of their ability to lose some or all of their investment. Zurich Life Assurance plc ('Zurich') recommends that the investor is sufficiently informed about financial markets or that they have received appropriate professional advice to ensure they are aware that the value of this investment will move up and down with the performance of the assets.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 7 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Summary Risk Indicator (SRI)

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because Zurich is not able to pay you. Zurich has classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of Zurich to pay you. If Zurich is not able to pay you what is owed, you could lose your entire investment. This fund does not include any protection from future market performance so you could lose some or all of your investment.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 12 years. Performance Scenarios

The figures shown include all the costs of the product itself, and includes the costs of your advisor or distributor.
